

Competition Terms & Conditions

Hennie's Buffalo Hunting Experience Competition

March 2026

This Hennie's Buffalo Hunting Experience Competition ("Competition"), proudly sponsored by Buffalo Trace and brought to you by Hennie's Sports Bar (Pty) Ltd ("Hennie's"), is offered subject to the terms and conditions set out below.

Participation by entrants in the Competition constitutes an agreement to abide by all these terms and conditions. Hennie's reserves the right to disqualify any entrant who breaches any provision(s) hereof. Where reference is made to the "Winner", it includes the Winner and their nominated friend.

These Terms and Conditions have been drafted to preserve the integrity and viability of the buffalo hunt, ensuring that it proceeds as planned. This is essential because all meat harvested from the hunt is committed to donation to The Christa Foundation (the official charity associated with Hennie's), where it will be used to support charitable causes benefiting communities in need.

1. WHO CAN ENTER?

1.1. Entry is only available to entrants who meet the following criteria:

- Must be aged 18 years and older upon entry;
- International entrants are welcome, but must be legally permitted to enter South Africa and possess all required documentation (valid passport, visa if applicable, etc.) at their own cost;
- Must be medically and physically fit and competent to participate in buffalo hunting activities (for instance, but not limited to, exclusion of individuals with epilepsy). The Winner and its nominated friend hereby agrees to sign a competency and acceptance of liability document as part of the vetting process and hereby agrees to sign the relevant indemnity form at Nahla Safaris;

- To ensure that the winner feels comfortable (and in an informed position) to accept the prize (in addition to the liability and risk associated with the activity of the prize) the winner will be granted an opportunity to have a telephonic conversation with the outfitters that will be facilitating the hunt. Four working days will be granted to arrange this conversation. Should the winner prior or following the conversation opt not to accept the prize he/she understands that they will then forfeit the prize in its totality and will not be offered a different prize, reimbursed, credited or be granted an opportunity to transfer the prize to anyone (refer to paragraph 5.1). In this instance, Hennie's will redraw a new winner. Should the second in line winner also forfeit the prize, Hennie's will be in its right to nominate its own two individuals to attend the trip.

1.2. Both the Winner and their nominated friend must meet all eligibility requirements set out herein.

1.3. Any person who enters or attempts to enter by fraudulent means will be disqualified. Employees, officers, contractors, franchisees, and their immediate families (spouse, children, parents, siblings) of Hennie's, Buffalo Trace or agencies/companies associated with this Competition are ineligible.

2. HOW TO ENTER

2.1. Purchase a "Dirty Buffalo" at any participating Hennie's location to receive one entry.

2.2. Complete your entry card and place it in the entry box.

2.3. Multiple entries are permitted.

2.4. Hennie's will not accept responsibility for entries that are incomplete, illegible, lost, mislaid, damaged, contain false information, or delayed in transit regardless of cause.

3. COMPETITION TIMELINES

- 3.1. The Competition commences on 12 March 2026 and ends at 23h00 on 12 April 2026.
- 3.2. Draw Process: Following the Competition end date, a two-stage draw will be conducted:
 - 3.2.1. Stage 1: Each participating Hennie's branch will conduct a live draw from their entry box and select one branch finalist;
 - 3.2.2. Stage 2: All branch finalists' names will be submitted to Hennie's head office, placed in a draw, and one final Winner will be selected.
- 3.3. Following the final draw, Hennie's will vet the potential winner to ensure compliance with all entry requirements. The Winner will be announced within 10 business days of 12 April 2026.
- 3.4. Hennie's will attempt to contact the potential winner via telephone and email for a maximum of 48 hours. If unreachable within this timeframe, they forfeit the prize and a new winner will be drawn.
- 3.5. Once contacted, the potential winner has 48 hours to nominate their friend. The friend must also meet all eligibility criteria set out in clause 1.
- 3.6. The potential winner and their friend must provide proof of identity, age, and any required travel documentation and the relevant competency document provided to it within 6 business hours of request (business hours: 8am-5pm).
- 3.7. The potential winner and their friend consent to background checks. Should:
 - The winner fail these checks, in the sole and absolute discretion of Hennie's, or not comply with the Competition terms, or opt not to accept the prize, he or she (plus their nominated friend) forfeit the prize and a new winner will be drawn. Should the latter however occur less than a month before the trip, Hennie's will be in its right not to draw a new winner but rather to nominate two individuals of their own choosing to attend the trip;
 - Should the nominated friend fail these checks, in the sole and absolute discretion of Hennie's, or not comply with the Competition terms or not be able to attend the trip, the nominated friend will forfeit the prize and the winner will be entitled to nominate another friend with the same process as stipulated in paragraph 3.5 and 3.6 (given this occur more than one month before the trip). Should any one of the latter events however occur less than a month before the trip, then Hennie's will be in its right to nominate a competent attendee in its stead at that time.

- Lastly, should the winner still be in its right to nominate a second friend as stipulated in the point above and this second nominated friend also fail the checks / not comply with other terms or not be able to attend the trip, then Hennie's will be in its right to nominate a competent attendee in its stead at that time.

3.8. The potential winner and friend may NOT announce or claim publicly that they are winners until Hennie's has formally announced the Winner. Hennie's takes no responsibility for embarrassment or inconvenience caused by premature announcements.

4. THE PRIZE

4.1. The prize includes a 2-night buffalo hunting experience at Nahla Safaris, Schweizer-Reneke, South Africa (physical address will be communicated) planned for the weekend of 16 July 2026 (subject to change per clause 5.4) for the Winner and one nominated friend.

4.2. INCLUSIONS:

- 2 nights' accommodation at Nahla Safaris;
- All meals (breakfast, lunch, dinner);
- Reasonable drinks (normal beers, brandy, soft drinks, mixers, water). Excessive consumption or request for high end liquor (including shooters) is for the Winner's account;
- Two mature Cape Buffalos (one for Winner, one for friend);
- Professional hunter services and tracker fees;
- Usage of the outfitters .375 calibre rifle;
- Ammunition.

4.3. EXCLUSIONS (at Winner's cost):

- Flights and all travel to/from Nahla Safaris;
- Ground transport to/from Nahla Safaris;
- Taxidermy and trophy stuffing services;
- Trophy export permits and veterinary certificates;
- Gratuities and tips for staff;
- Personal spending and bar account for excessive drinks;
- Travel insurance;

- Temporary firearm import permits (if bringing own firearm into South Africa);
- All required passports, visas, permits, and travel documentation if Winner/friend is not South African.

IMPORTANT: All meat from the buffalo hunts will be donated to The Christa Foundation and is not available for the Winner or friend to take home. The Winner and friend may take their trophy horns/skull provided this does not interfere with the meat donation.

4.4 TROPHY EXPORT, CITES AND FIREARM IMPORT REQUIREMENTS

The Winner and nominated friend acknowledge that the Cape Buffalo (*Syncerus caffer*) is listed on CITES Appendix II. Export of any trophy (horns or skull) from South Africa therefore requires a CITES export permit issued by the relevant South African authority (Department of Forestry, Fisheries and the Environment or the applicable provincial conservation authority), together with any veterinary health certificates and other export documentation mandated by South African law.

The Winner and nominated friend are **solely and exclusively responsible**, at their own cost and risk, for: • obtaining the CITES export permit and all related South African export documentation; • complying with the import laws, permit requirements, restrictions, bans or additional certifications of their country of residence (and any transit countries); • all application fees, processing times, courier costs, storage fees, and any other expenses arising from the above; and • any delays, refusals, seizures or confiscations by South African or foreign customs authorities.

Hennie's, Buffalo Trace and Nahla Safaris provide **no assistance** whatsoever with CITES applications, veterinary certificates, export or import permits, and give **no guarantee or warranty** that the trophy horns or skull can be successfully exported from South Africa or imported into the Winner's home country. In the event that the trophy cannot be exported or imported for any reason whatsoever, it shall remain in South Africa at the sole cost and risk of the Winner and nominated friend. No refund, compensation, credit or alternative prize will be offered.

If the Winner or nominated friend elects to bring their own firearm instead of using the outfitter's provided .375 calibre rifle, they must obtain a SAPS 520 Temporary Import Permit (and comply with all South African Police Service and Customs requirements) at the port of entry. Failure to do so may result in the firearm being refused entry or confiscated, with no liability on the part of Hennie's, Buffalo Trace or Nahla Safaris.

5. OTHER TERMS AND CONDITIONS

- 5.1. The prize is not transferable, exchangeable, or replaceable for cash. No refunds or credit will be issued.

- 5.2. The trip is planned for the weekend of 16 July 2026. Hennie's and the outfitter reserve the right to change the exact dates based on availability, hunting season requirements, or other factors beyond their control. The Winner will be notified of any date changes as soon as reasonably possible. Hennie's and the winner and Nahla Safaris will provide their best endeavours to then seek an alternate date for the hunt that suits all Parties. However, should an alternate date not be possible at that time, Hennie's will be allowed to nominate a new winner and friend in its stead;
- 5.3. The Winner and friend may be required to sign additional indemnities, liability waivers, and other documentation required by Nahla Safaris before or upon arrival;
- 5.4. Hennie's reserves the right to substitute the prize with one of equal value if circumstances beyond its control make the advertised prize unavailable;
- 5.5. All bookings are subject to availability at Nahla Safaris and the outfitter's terms and conditions apply;
- 5.6. Hennie's reserves the right to change these terms and conditions at any time via the Hennie's website (www.therealhennies.co.za) at any time during the Competition;
- 5.7. These terms and conditions are governed by the laws of the Republic of South Africa.

6. LIABILITY

- 6.1. To the maximum extent permitted by law, Hennie's Sports Bar (Pty) Ltd, Buffalo Trace, their respective holding, subsidiary, associated and interrelated companies, directors, officers, employees, agents, and franchisees shall (in addition to any liability waiver signed at Nhala Safaris) not incur any liability for any injury, loss, claim, damage or death of any nature whatsoever suffered by the winner or the friend (whether direct, indirect, or consequential) arising from:
- 6.1.1. Participation in this Competition;
- 6.1.2. Acceptance or use of the prize;

- 6.1.3. Participation in buffalo hunting activities, which are inherently dangerous.
- 6.2. The prize is accepted and utilised at the sole risk of the Winner and their friend. Both parties acknowledge that buffalo hunting is a dangerous activity that may result in serious injury or death.
- 6.3. In the event of Force Majeure (including but not limited to acts of God, strike, war, rebellion, riot, civil commotion, fire, accident, governmental lockdowns, pandemics, or any circumstances beyond the reasonable control of Hennie's), Hennie's shall be relieved of all obligations to the Winner during the period such Force Majeure continues and shall not be liable for any delay, failure, or loss suffered by the Winner.
- 6.4. Hennie's reserves the right to cancel, suspend, or terminate the Competition at any time without notice. In the event of disputes, Hennie's decision is final and binding. No correspondence will be entered into.

7. PROTECTION OF PERSONAL INFORMATION

- 7.1. Hennie's collects entrants' and Winners' personal information to conduct the Competition. If the requested information is not provided, the entrant may not participate. Hennie's will not disclose this information to anyone other than contractors providing services for this Competition unless compelled or permitted by law.
- 7.2. Winners' names and images may be published on Hennie's and Buffalo Trace's social media platforms, websites, and other marketing materials. By entering the Competition, entrants agree to receive further communication and direct marketing from Hennie's, Buffalo Trace, and SA Breweries. Entrants may opt-out of commercial communications at any time via the opt-out mechanisms provided.
- 7.3. This Competition complies with the Consumer Protection Act ("CPA") and the Protection of Personal Information Act ("POPIA"). In the event of conflict between these terms and applicable legislation, the legislation shall prevail. Copies of the CPA are available at <http://www.thedtic.gov.za/>.

8. CONSENT

- 8.1. By entering this Competition, entrants voluntarily consent to:

- 8.1.1. Hennie's processing their personal information (name, telephone number, email, identity number) during and after the Competition;
- 8.1.2. Hennie's transferring their personal information to Nahla Safaris and other third parties to make required travel and hunting arrangements;
- 8.1.3. Hennie's and Buffalo Trace capturing and using their name, image, photographs, videos, and other media for promotional purposes without remuneration;
- 8.1.4. Participation in promotional activities as reasonably requested by Hennie's or Buffalo Trace.

Entrants acknowledge they will have no proprietary rights in any media produced.
