

Competition Terms & Conditions

Hennie's – Mother's Day Weekend Away Competition

May 2026

This Hennie's Mother's Day Weekend Away Competition ("Competition"), proudly sponsored by SA Breweries and brought to you by Hennie's Sports Bar (Pty) Ltd ("Hennie's"), is offered subject to the terms and conditions set out below.

Participation by entrants in the Competition constitutes an agreement to abide by all these terms and conditions. Hennie's reserves the right to disqualify any entrant who breaches any provision(s) hereof. Where reference is made to the "Winner", it includes the Winner and their nominated guest.

1. WHO CAN ENTER?

1.1. Entry is only available to entrants who meet all of the following criteria:

- Must be aged 18 years and older upon entry;
- Must nominate as their guest a person they regard as their mother, including a biological mother, stepmother, mother-in-law, adoptive mother, or other maternal figure ("Nominated Guest");
- Entrants residing outside of South Africa must hold a valid passport at the time of entry and for the duration of the prize trip, and must be legally permitted to travel to and enter South Africa. All costs related to travel documentation are for the entrant's own account (Temporary/Emergency/Still in Print Passports will not be accepted);
- Be in possession of passport(s) that are valid until at least 31 January 2027;
- Have a minimum of three blank pages next to each other available for visa purposes (if applicable).

1.2. Any person who enters or attempts to enter by fraudulent means will be disqualified.

1.3. Employees, officers, contractors, franchisees, and their immediate families (spouse, children, parents, siblings) of Hennie's, SA Breweries, or of the agencies or companies associated with this Competition, are ineligible.

2. HOW TO ENTER

2.1. Purchase a bucket of 4 (four) Brutal Fruit Rossa at any participating Hennie's location during the Competition period to receive one entry card.

2.2. Complete all required contact details on the entry card in order to qualify.

- 2.3. Place the completed entry card into the designated entry box at the participating store.
- 2.4. Multiple entries are permitted; each qualifying purchase constitutes one entry.
- 2.5. Hennie's will not accept responsibility for entries that are incomplete, illegible, lost, mislaid, damaged, contain false information, or delayed in transit, regardless of cause.

3. COMPETITION TIMELINES

- 3.1. The Competition commences on 4 May 2026 and ends at 23h00 on 10 May 2026. The Competition is open to all participating Hennie's locations in South Africa and Namibia.
- 3.2. Draw Process: Following the Competition end date, a two-stage draw will be conducted:
 - **Stage 1:** Each participating Hennie's branch will conduct a live draw from their entry box and select one branch finalist;
 - **Stage 2:** All branch finalists' names will be submitted to Hennie's head office, placed in a draw, and one final Winner will be selected.
- 3.3. Following the final draw, Hennie's will vet the potential winners to ensure compliance with all entry requirements. The Winners will be announced within 10 business days of the competition closing date via Hennie's official social media platforms.
- 3.4. Hennie's will attempt to contact each potential winner via telephone and/or email for a maximum of 48 hours. If a potential winner is unreachable within this timeframe, they will forfeit the prize and a new winner will be drawn.
- 3.5. Once contacted, the potential winner must confirm the identity of their Nominated Guest within 48 hours. The Nominated Guest must also meet all applicable eligibility criteria set out in clause 1.
- 3.6. The potential winner and their Nominated Guest must provide proof of identity and age and any required travel documentation, including passport within 24 business hours of request (business hours: 8am-5pm).
- 3.7. Please note: NO additional time will be afforded for the printing of a passport or for obtaining a temporary (emergency) passport or to reapply for a new passport.
- 3.8. The potential winner and their Nominated Guest may NOT announce or claim publicly or privately that they are the winner(s) until Hennie's has formally published the announcement. Hennie's takes no responsibility for any embarrassment or inconvenience caused by a premature announcement.

3.9. The potential winner and their Nominated Guest consent to any background and other relevant checks conducted in the sole and absolute discretion of Hennie's.

4. THE PRIZE

4.1. There will be 2 (two) Winners, each of whom will receive an all-expenses-paid weekend away for themselves and their Nominated Guest at Daai Plekkie in die Weskus, Jakobsbaai, on the West Coast of South Africa. The exact dates in June 2026 will be arranged directly with Daai Plekkie in die Weskus and communicated to the Winners accordingly.

4.2. Inclusions:

- Accommodation at Daai Plekkie in die Weskus, Jakobsbaai for a full weekend (Friday to Sunday);
- All meals (breakfast, lunch, and dinner) included for the duration of the stay; and
- Reasonable non-alcoholic and standard beverages included as part of the package (excessive consumption or premium drinks requested separately are for the Winner's own account).

4.3. Exclusions (at Winner's own cost):

- All travel to and from the Winner's location to Daai Plekkie in die Weskus, Jakobsbaai;
- Gratuities and tips for staff;
- Personal spending and any additional bar account for excessive drinks;
- All required passports, visas, permits, and travel documentation; and
- Any costs arising from upgrades, changes, or cancellations requested by the Winner.

5. OTHER TERMS AND CONDITIONS

5.1. The prize is not transferable, exchangeable, or replaceable for cash, and no refund or credit will be issued.

5.2. The trip is planned for June 2026. Hennie's reserves the right to adjust the exact dates based on availability at Daai Plekkie in die Weskus or other factors beyond its control. The Winner will be notified of confirmed dates as soon as reasonably possible. Should an alternate date not be mutually agreeable, Hennie's reserves the right to nominate a new winner.

5.3. Hennie's reserves the right to substitute the prize with one of equal value if the advertised prize becomes unavailable for reasons beyond its control.

- 5.4. Should a Winner be unable to attend the trip, fail any eligibility requirement, or opt not to accept the prize for any reason, the prize is forfeited in its entirety by both the Winner and their Nominated Guest, without replacement, cash equivalent, or alternative prize.
- 5.5. Should only the Nominated Guest be unable to attend or fail any eligibility requirement:
- If this occurs more than one month before the trip date, the Winner may, at Hennie's sole discretion, nominate an alternative guest, subject to the same eligibility and vetting process;
 - If this occurs less than one month before the trip date, the Nominated Guest's portion of the prize is forfeited without replacement and the Winner may proceed unaccompanied.
- 5.6. It is the sole responsibility of Winners and their Nominated Guests residing outside of South Africa to ensure they hold all documentation required to enter South Africa. Hennie's accepts no liability for any refusal of entry at the border for any reason whatsoever. Should a Winner be refused entry into South Africa, the prize is forfeited in its entirety without replacement, cash equivalent, or alternative prize. Should only the Nominated Guest be refused entry, the consequences set out in clause 5.5 apply accordingly.
- 5.7. Hennie's reserves the right to amend these terms and conditions at any time by publication on its website (www.therealhennies.co.za) during the Competition period.
- 5.8. These terms and conditions are governed by the laws of the Republic of South Africa.

6. LIABILITY

- 6.1. To the maximum extent permitted by law, Hennie's Sports Bar (Pty) Ltd, SA Breweries, their respective holding, subsidiary, associated, and interrelated companies, directors, officers, employees, agents, and franchisees shall not incur any liability for any injury, loss, claim, damage, or death of any nature whatsoever suffered by the Winner or their Nominated Guest (whether direct, indirect, or consequential) arising from:
- Participation in this Competition;
 - Acceptance or use of the prize; or
 - Participation in any activities at Daai Plekkie in die Weskus, Jakobsbaai, which is entirely at the participants' own risk.
- 6.2. In the event of Force Majeure (including but not limited to acts of God, strike, war, riot, fire, accident, governmental restrictions, pandemics, or any circumstances beyond the reasonable control of Hennie's), Hennie's shall be

relieved of all obligations to the Winner during the period such Force Majeure continues and shall not be liable for any delay, failure, or loss suffered.

- 6.3. Hennie's reserves the right to cancel, suspend, or terminate the Competition at any time without notice. In the event of any dispute, Hennie's decision is final and binding and no correspondence will be entered into.

7. PROTECTION OF PERSONAL INFORMATION

- 7.1. Hennie's collects entrants' and winners' personal information in order to conduct the Competition. If the requested information is not provided, the entrant may not participate. Hennie's will not disclose this information to anyone other than contractors providing services for this Competition, unless compelled or permitted by law.
- 7.2. Winners' names and images may be published on Hennie's and SA Breweries' social media platforms, websites, and other marketing materials.
- 7.3. By entering the Competition, entrants agree to receive further communication and direct marketing from Hennie's and SA Breweries. Entrants may opt out of commercial communications at any time via the opt-out mechanisms provided.
- 7.4. This Competition complies with the Consumer Protection Act ("CPA") and the Protection of Personal Information Act ("POPIA"). In the event of conflict between these terms and applicable legislation, the legislation shall prevail. Copies of the CPA are available at <http://www.thedtic.gov.za/>.

8. CONSENT

- 8.1. By entering this Competition, entrants voluntarily consent to:
- Hennie's processing their personal information (name, telephone number, email address, and identity number) during and after the Competition;
 - Hennie's transferring their personal information to Daai Plekkie in die Weskus and other relevant third parties to make required accommodation arrangements;
 - Hennie's and SA Breweries capturing and using their name, image, photographs, videos, and other media for promotional purposes without remuneration; and
 - Participation in promotional activities as reasonably requested by Hennie's or SA Breweries.

8.2. Entrants acknowledge they will have no proprietary rights in any media produced.
