

Competition Terms & Conditions

Hennie's #VISITHENNIES2026 Reel Competition

Launch: 7 April 2026

This #VISITHENNIES2026 Reel Competition ("**Competition**"), brought to you by Hennie's Sports Bar (Pty) Ltd ("**Hennie's**" / "**we**" / "**us**"), is offered subject to the terms and conditions as set out below.

Your participation in the Competition constitutes your agreement to abide by all the terms and conditions set out below. We reserve the right to disqualify you if you breach any provision(s) of these terms and conditions.

COMPETITION OVERVIEW

1. One (1) cash prize of R30,000.00 (thirty thousand rand) is available to be won ("**Prize**"). The prize will be EFT to the winner upon proof of account submitted.
 - 1.1 Hennie's shall not be liable for any incorrect banking details provided.
2. This Competition runs from **7 April 2026 at 12:00 to 31 May 2026 at 12h00 (midday)**.
3. The winner will be determined based on the **highest view count total on Instagram AND TikTok** as depicted on the submission on **31 May 2026 before 12:00 and verified for authenticity on the relevant platform**.
4. **Therefore, each contestant must post on Tiktok and Instagram and both views will be combined when determining the winner. The most combined views, wins.**

ELIGIBILITY

5. You must be 18 (eighteen) years of age or older to enter this Competition. Minors (persons under 18 years of age) may participate only if assisted by and with the written consent of their parent or legal guardian.
6. You may post as many videos as you wish per platform, however only one video per platform can be submitted for purposes of assessment (view counting) to determine if you are the winner.
7. Employees of Hennie's Sports Bar (Pty) Ltd, its affiliates, franchisees, and their immediate family members are not eligible to participate in this Competition.
8. Residents of Namibia are also allowed to enter.

HOW TO ENTER THE COMPETITION

9. **Create Your Reel:**
 - 9.1 Create an entertaining reel / video that promotes the Hennie's experience with the same brand intent and positive sentiment that Hennie's promotes.
 - 9.2 NB no photographs will be considered.

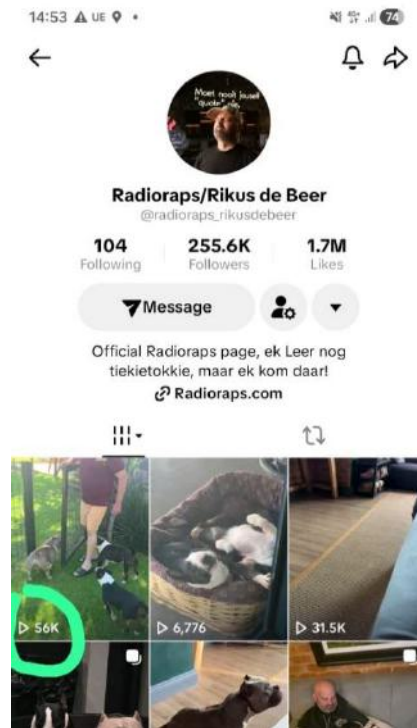
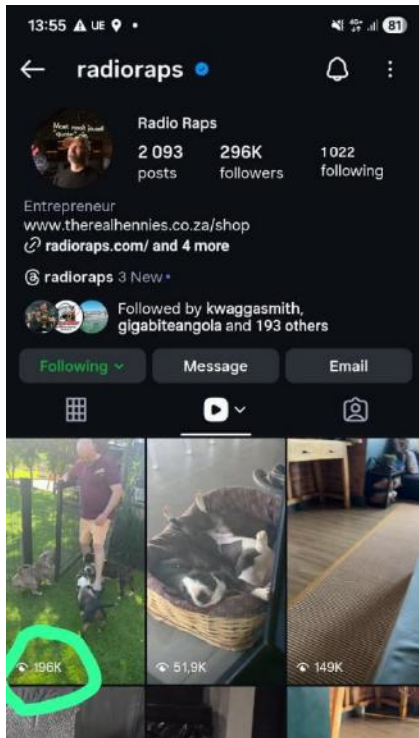
- 9.3 The reel **must be filmed at / in a Hennie's branch**. The branch location must be clearly identifiable in the reel and tagged, for example #henniespaarl or #henniescenturion. The name of the branch is per the branch badge, visible on www.therealhennies.co.za.
- 9.4 The reel / video **must end with the phrase**: "*Hennie's – dis nie vir almal nie, net vir lekker mense*" OR *Hennie's - not for everyone, just for lekker people*".
- 9.5 The reel must be appropriate for all audiences and may not contain offensive, defamatory, or inappropriate content about Hennie's or any other persons.

10. Post Your Reel:

- 10.1 You must post your reel on **Instagram and TikTok**. The reel / video view count is only counted per platform to determine your total views.
- 10.2 Your post must include the hashtag **#visithennies2026** and the relevant branch as shown in 9.3.
- 10.3 Your post must tag **@therealhennies**.
- 10.4 Your account must be set to public to ensure we can verify your submission and view count.

11. Submit Your Entry:

- 11.1 To officially submit your entry, you must send an email to: entry@therealhennies.co.za
- 11.2 Your email must be sent **by 31 May 2026 before 12:00**
- 11.3 The views on your email will be the views we will consider to determine your entry.
- 11.4 You may post as many videos as you wish per platform, however only one video per platform can be submitted for purposes of assessment (view counting) to determine if you are the winner. Example below.
- 11.5 We therefore suggest that you take a screenshot of the views as close to 31 May 2026 at 12h00 as possible.
- 11.6 No emails after 31 May 2026 at 12h00 received will be considered.
- 11.7 Your email must include:
 - (a) A screenshot of your reel / video showing the current view count(s) per platform (so two screenshots) – example below
 - (b) Your social media account name(s) where the reel was posted and links thereto;
 - (c) A link or links to your reel post(s);
 - (d) Your full name, contact telephone number, email address, and ID number / passport number; and
 - (e) Confirmation that you have read and agreed to these terms and conditions.
12. Entries received after the deadline of **31 May 2026 12:00** will be automatically disqualified, regardless of when the reel was posted.



WINNER SELECTION AND VERIFICATION

13. View counts will be checked against the two platforms and the email submission on **31 May 2026** to determine the winner.
14. The entry with the **highest view count** on Instagram plus TikTok as of **31 May 2026, 12:00** will be declared the winner, within 7 (seven) working days.
15. In the event of a tie (equal view counts), the entry that was submitted via email first will be declared the winner.
16. We reserve the right to verify all aspects of your entry, including but not limited to:
 - (a) That the reel was filmed at a Hennie's branch;
 - (b) That view counts are genuine and not artificially inflated;
 - (c) That all content requirements have been met;
 - (d) That you are the legitimate owner of the social media account(s); and
 - (e) That your identity and eligibility to participate.
17. You must cooperate fully with any verification requests. Failure to provide requested verification within 7 (seven) calendar days of our request will result in automatic disqualification, and the Prize will be awarded to the entry with the next highest view count.
18. We reserve the right to disqualify any entry that we reasonably believe:
 - (a) Contains false, misleading, or fraudulent information;

- (b) Involves manipulation of view counts, including but not limited to the use of bots, or other fraudulent means;
 - (c) Violates any provision of these terms and conditions;
 - (d) Contains content that is offensive, defamatory, inappropriate, or violates any law or regulation;
 - (e) Violates the intellectual property rights of any third party; or
 - (f) Is contrary to the spirit or intention of the Competition.
19. The winner will be paid within 7 (seven) working days of it adhering to all the terms herein.
 20. The winner has 3 calendar days to respond to our communication that you are indeed the winner. If you are unreachable in this time another winner will be drawn.
 21. The winner will have to agree to meet with a representative of Hennie's to sit next to them and login to their submitted Instagram and TikTok account to ensure credit is not being taken on someone else's profile.
 22. Our decision regarding verification, winner selection, and disqualification is final and binding. No correspondence will be entered into.

THE PRIZE

23. The Prize consists of R30,000.00 (thirty thousand rand) in cash, payable via EFT.
24. The winner must provide the following information within 7 (seven) days of being contacted:
 - (a) Full legal name as it appears on their ID / passport;
 - (b) Contact telephone number and email address;
 - (c) Proof of banking details supplied by your bank, in which the prize money will be transferred;
 - (d) Signed acknowledgment of receipt of the Prize and agreement to publicity terms (if applicable).
 - (e) The video file of the reel / video, in a quality format as posted, via WeTransfer or Similar file transfer service.
 - (f) An invoice reflecting the amount payable.
25. Failure to provide the required information within 7 days will result in forfeiture of the Prize, and we may award it to the entry with the next highest view count.
26. The Prize will be paid via electronic funds transfer (EFT) to the winner's nominated bank account within 7 working days of receiving all required information and documentation.
27. The Prize is not transferable, not exchangeable, and has no alternative cash value. You may not sell, assign, or transfer your right to receive the Prize to any other person.
28. The winner is solely responsible for any tax implications arising from receipt of the Prize, including but not limited to income tax. We recommend that the winner seeks independent tax advice.
29. We reserve the right to substitute the Prize with an alternative prize of equal or greater value in the event that payment of the Prize becomes impossible or impractical for any reason beyond our reasonable control.

CONTENT RIGHTS AND USAGE

30. By entering this Competition, you grant Hennie's Sports Bar (Pty) Ltd a perpetual, worldwide, royalty-free, non-exclusive license to use, reproduce, modify, adapt, publish, and display your submitted reel content for marketing, promotional, and commercial purposes across all media platforms.
31. You warrant that:
- (a) You are the original creator of the reel content;
 - (b) You own all rights to the content, including music, images, and any other elements;
 - (c) Your content does not infringe on any intellectual property rights of any third party;
 - (d) You have obtained all necessary permissions and consents from any individuals appearing in your reel; and
 - (e) The content complies with all applicable laws and regulations.
32. You agree to indemnify and hold harmless Hennie's Sports Bar (Pty) Ltd against any claims arising from your breach of the warranties in clause 30 above or any other damages that may flow from posting of your video.

GENERAL TERMS

33. We reserve the right to cancel, suspend, modify, or terminate this Competition at any time without prior notice for any reason, including but not limited to fraud, technical difficulties, or circumstances beyond our reasonable control.
34. We reserve the right to amend these terms and conditions at any time. Amended terms will be published on our website (www.therealhennies.co.za) and/or announced on our social media channels. Your continued participation after amendments constitutes acceptance of the amended terms.
35. All intellectual property rights in the Competition, including but not limited to the Competition name, logos, promotional materials, and brand elements, belong to Hennie's Sports Bar (Pty) Ltd.
36. We are not responsible for:
- (a) Any technical failures on Instagram, TikTok, or any other social media platform;
 - (b) Internet connectivity issues, email delivery failures, or social media platform outages;
 - (c) Lost, late, misdirected, or incomplete entries;
 - (d) Any costs incurred by you in participating in the Competition, including but not limited to data costs, travel expenses, production costs, or any other expenses;
 - (e) Changes to social media platform algorithms or policies that may affect view counts; or

- (f) Any damage to your property or person arising from your participation in the Competition.
37. You indemnify and hold harmless Hennie's Sports Bar (Pty) Ltd, its directors, employees, agents, franchisees, and affiliates against any and all claims, damages, losses, costs, and expenses arising from your participation in the Competition or your breach of these terms and conditions.
38. These terms and conditions are governed by the laws of the Republic of South Africa. Any disputes arising from this Competition shall be subject to the exclusive jurisdiction of the South African courts.

PUBLICITY, PERSONAL INFORMATION, AND CONSENT

39. Hennie's collects entrants' and winner's personal information in order to conduct the Competition. If the information requested is not provided, the entrant may not be able to participate in the Competition. Hennie's will not disclose this information to anyone other than contractors who provide services to Hennie's for the purposes of conducting this Competition unless compelled or permitted by law.
40. Entrants'/Winner's personal information may be disclosed, and the winner's name published on Hennie's social media platforms, website and other ancillary forums.
41. As per the relevant Data Privacy Legislation, a request to access, update or correct any information should be directed to the Privacy Officer of Hennie's. Entrants indemnify the promoters from any unintentional disclosures of such information to unauthorised persons.
42. The promoters may, after the winner has accepted the Prize, and both before or after the winner of the Competition has been publicly announced, request that the winner permits the use of their image/s and/or name/s in their marketing material and/or participate in their marketing activities (including endorsing, promoting and/or advertising the services of the promoters, or any of their subsidiary, holding, associated, related and inter-related companies).
43. By entering the Competition, entrants agree to receive further communication and direct marketing material from the promoters, and their respective holding, subsidiary, associated related and inter-related companies, provided that the entrants may opt-out of receiving commercial communications at any time via the appropriate opt-out mechanisms provided by the promoters for such purpose.
44. This Competition shall comply with, and will be subject to, any peremptory provisions of the Consumer Protection Act ("**CPA**") and the regulations promulgated thereunder, which are deemed to be incorporated herein ("**the Provisions**"). In the event of any conflict between these rules and the Provisions, the Provisions shall prevail. Any provision of these rules or the Competition which is held to be invalid or unenforceable shall be ineffective to the extent of such invalidity or unenforceability without invalidating or rendering unenforceable the remaining provisions thereof.

LIABILITY

45. To the maximum extent permitted in law, the owners of any Hennie's restaurant, the promoters, or any of their respective holding, subsidiary, associated, related and interrelated companies, or any of their respective directors, officers, managers, employees, agents, franchisees, or anyone associated with any of them, shall not incur any liability to any person for any injury, loss, claim or damage of any nature whatsoever whether direct, indirect, consequential or otherwise, as a result of (or in any way connected to) any person entering into, or arising from any cause whatsoever or howsoever arising from any person's participation in any way, in this Competition or as a result of (or in any way connected to) any prizes won, including any tax liability incurred by the winner (any such prizes being utilised and accepted at the sole and own risk of any winner thereof).
46. In the event of any act of God, strike, war, warlike operation, rebellion, riot, civil commotion, lockout, combination of workmen, interference of trade unions, suspension of labour, fire, accident, or (without regard to the foregoing enumeration) of any circumstances arising or action taken beyond or outside the reasonable control of the promoters preventing them from the performance of any obligation to an entrant or winner (any such event hereinafter called "**Force Majeure**") then the promoters shall be relieved of all such obligations to the entrant or winner during the period that such Force Majeure continues and shall not be liable for any delay or failure in the performance of any obligations or loss or damage which the entrant or winner may suffer due to or resulting from the Force Majeure. This includes governmental lockdowns.
47. In the event of a dispute in respect of any aspect of the Competition, the promoters' decision is final and binding and no correspondence will be entered into. In the event of a dispute regarding the winner chosen in accordance with the terms above, the decision of an independent admitted attorney duly appointed by the promoters will be final and binding and no other correspondence will be entered into.
